Progress Summary:

The Final Report has been delivered and accepted by the Working Group members, based on positive feedback from the Namoi Unlimited Mayors and General Managers presentation on the 5th October 2023. Each Working Group member will present the final strategy to their respective Council and leadership teams.

The Working Group are meeting in the week of the 8th November to identify the requirements of the Working Group to take this strategy forward and maintain momentum on the implementation.

The Department of Regional NSW has participated in the Working Group and have expressed commitment to be involved in the implementation going forward.

There was no representation from Liverpool Plains in the Working Group, however the Mayor and GM have been present at presentations. To address this potential gap, stakeholders from the region were invited to participate in the workshops and interviews. The Project Team are confident that the needs of the Shire were included in all research and findings.

An extension of one month from the original due date of the 30th September 2023 was requested and approved. This extension was required due to Covid related illness. The reporting requirements of the grant funding have all been met and the final reconciliation submitted. The grant value awarded was \$220,000. The project was delivered under budget (\$214,940), with an amount of \$5,060 allocated as contingency remaining unspent.


